principal character in "C'est le soleil qui m'a brulée" one of the literary works of Calixthe Beyala.

(QG) is a place with overcrowded and very old buildings in very bad conditions where poverty, prostitution and immorality of all kinds are on display, A place where women are constantly raped, and brutally beaten, molested, and exploited, Biddon Ville is a place known for its criminalities, rottenness and moral decay. This was the place Ateba grew up. A slum where prostitution flourished: Ateba was a child to a mother who was a prostitute, brought up by an Aunt Betty who was a prostitute and she herself "Ateba" who also was not left in the circle. Ateba ended by killing a man who came to rape her in the process of defending and fighting for her freedom. Hear Ateba, while trying to defend herself from a brutal and violent attack by a rapist.

As if that was not enough, she abandoned the child, Ateba was left at the mercy of her niece who was not only a prostitute with so many concubines, but also very morally indecent that Ateba too became a victim of the very life style of her mother and niece, exposed to all forms of abuse, exploitation, rape and man's inhumanly to man. All these evils happened to Ateba because her mother "BETTY" abandoned her. According to Marie Aimée Hélie-lucas the number of





children abandoned in Africa are so much, this to her is a new phenomenon in Africa, hear her.

Twenty years ago, this didn't exist at all. It's a new phenomenon, which is appearing in all African capitals. I don't know about elsewhere, but I know about Africa.

This act of abandoning children has become a norm in the African soil. In many major cities of Africa, children are seen roaming the streets aimlessly, some with plates in their hands, a lot of them putting on tattered clothes, many of them bare footed begging for alms and food. The Author "Calixthe Beyala used Cameroon, her own country as case study to expose the pains, challenges and crisis the African woman and children are going through. In our own country Nigeria, the situation is even worse, because of the biting economic conditions and the extremely harsh economic policies especially since the era of Buhari's administration till today, a lot of cases of divorce have been recorded, children's living conditions have deteriorated because poverty and hardship have been hitting hard on parents. I use Lafia, the capital of Nasarawa state as case study where a lot of children who were attending schools before have dropped out, I have interviewed several parents and most of them end up with" the times are very hard. We can hardly eat food once a day, so school or education must wait. This is the true picture of the situation; children are seen in motor parks, inside and around market gates desperately begging for alms, they sleep where ever night catch up with them. These children were born by a man and woman coming together to have sexual pleasures for selfish desires without bothering to think that the children that will follow their selfish and ungodly desires will need care and attention. Hardship has made a lot of men to refuse to get married, many that were married have abandoned their wives, running away from their responsibilities because they do not seem ready in any way to bear the heavy burden of being a responsible father or mother. The society can never be well as long as parents are not ready to face their responsibilities, these responsibilities will be made easier for parents when the policies of government are people friendly and are geared towards addressing the needs of the poor masses.

The present economic condition in Nigeria, has made many women to become like "Betty the mother of Ateba" who had to abandon her daughter for prostitution and hooliganism. The same hardship that made Ateba's mother to become a





prostitute due to exposure to all forms of challenges of life, including lack of parental care, bad government policies and unbearable living conditions have pushed so many women in Nigeria today into these very irresponsible and ungodly life styles. Many men and women out of frustration and unbearable hardships have abandoned their families, gone into drinking of alcohol and drug abuse, (both men and women). Prostitution is now seen as a kind of soft landing for girls and women while men are into yahoo practices and kidnapping. This is the ugly case of Africans particularly Nigeria. The very big question is "will things ever get better?"

CONCLUSION

This article has exposed the short comings of Betty as an irresponsible mother, who gave birth to Ateba her daughter for a man she could not identify. Government should make loans/funds available for young people to start small businesses and ensure that the interest of such loans are within single digits and good time space provided for repayment so that they will be able to face their responsibilities as fathers and mothers.

Non-governmental bodies and spirited individuals should be of help to vulnerable children and the poor masses in the society. These can be achieved through making education in primary and junior secondary schools free and compulsory for every child of school age.

Very harsh laws must be made by government to punish any man or woman who decides to abandon his or her family.

If government, non-governmental organizations, religious bodies and spirited individuals in the society can do these and more, by the grace of God, our society will gradually begin to change for the better and humanity will begin to experience better living conditions as these measures will help to drastically reduce the sufferings and hardship of the vulnerable people and the very poor masses in our society.
